#### What does Historic Environment Scotland do?



Historic Environment Scotland (HES) is a charity and public body that looks after Scotland's **historic environment** and tells people about it.





- places and things that show us what happened in the past, like a castle or garden, or things like books or maps
- cultural heritage like stories, crafts, and traditions – thinking or behaviour that has happened for a long time



Our **vision** is that Scotland's historic environment is looked after, understood, shared and enjoyed by everyone.

Our **vision** is what we want to happen.

#### What is the Annual Operating Plan?



The Annual Operating Plan sets out the work that Historic Environment Scotland will do from April 2024 to the end of March 2025 to deliver the **outcomes** in our Corporate Plan 'Heritage for All'.

An **outcome** is what we want to see happen in the long term.

#### What we want to achieve



The 5 **outcomes** from Heritage for All are:

- 1. People benefit from the historic environment today
- 2. The historic environment is looked after so people can benefit from it in the future



3. The historic environment supports Scotland's **economy** 

Our **economy** is how the country produces and uses goods, services and money.



- 4. The historic environment **inspires** people this means:
  - it makes them feel positive
  - it gives them ideas
  - it makes them want to do new things or change things



- 5. The historic environment is cared for by a **high performing organisation** this means an organisation that:
  - works well
  - has good leaders and skilled staff
  - makes good decisions and delivers good work



We will review our Corporate Plan and its outcomes in 2024-25.

A **review** is when something is looked at to see if it is working well and what needs to change.

#### Checking if work is going well



Our Corporate Plan has 10 statements called Key Performance Indicators (KPIs) highlighted in blue that we will use to check if we are achieving our outcomes.

We can show we are achieving these KPIs by doing the work in the Annual Operating Plan.



Annual Operating Plan progress is reported to our Executive Leadership Team and HES Board every 3 months.

Results are published in our Annual Report and Financial Statements.



## People benefit from the historic environment today





#### Why it matters

The historic environment has the power to change lives for the better:

- to build the wealth and wellbeing of our communities

#### **Communities**

We will help communities benefit from the historic environment in their area.

#### Why it matters

We must:

- look after and reuse our heritage
- adapt it to meet the needs of a changing climate so it is kept safe for the future

Climate change is the way the world's weather and temperature are changing because there is too much carbon dioxide gas in the air.



We must change the way HES and heritage organisations work so we can achieve Scotland's goal of **net zero carbon emissions** by 2045.

This means finding ways to put less carbon dioxide gas into the air.



**KPI 4 Strengthen the resilience of Scotland's historic environment** 

**Resilience** means being better at dealing with difficult things.

#### **Estate management**

We will do the work in our Estate Plan to look after the properties in our care.



#### Strategy for 'properties in our care'

We will make a long term plan to manage the properties in our care in a sustainable way.

**Sustainable** means our work will last for a long time and is good for the environment.



#### **Collections**

We will look after the **object collections** linked with the properties in our care.

**Object collections** means things like parts of buildings, costumes, coins and paintings.



#### **Archive House**

We will have better ways to store our **archives**.

**Archives** are historical records like drawings, maps and photographs.



#### Research

This means getting facts, figures and information.



We will do the work in our research strategy to support our work on:

- climate change
- improving equalities
- new ideas and ways of working



#### **Edinburgh Castle**

We will develop a plan for Edinburgh Castle to make sure it benefits everyone now and in the future.

Lead the historic environment sector in climate change action

#### **HES** emissions

We will do the work in our Carbon

Management Plan so that we produce less
carbon dioxide from our work.



#### **Climate change adaptation**

We will do the work in our Climate Action Plan to support and promote ways of working that are good for the environment.

#### Why it matters

Our historic environment creates jobs and attracts millions of visitors to Scotland each year, bringing in hundreds of millions of pounds to our economy.

We want to look after our heritage and the role it can play in building a fairer future.



KPI 6
Increase economic benefits

#### Casework

We will deal with requests for consents, consultations and decisions in the planning system on time.

The **planning system** controls change of use of land and buildings and the design of buildings.



#### **Growth deals**

We will support the historic environment being included in national and regional economic and investment plans.



#### **Tourism**

We will increase the number of visits to properties in our care in a way that:

- is good for local tourism
- avoids harm to communities and the environment



#### Visitor experience

We will help people have a good time when they visit our properties.



#### **Grants**

We will invest in historic places across Scotland through our grant programmes to bring more money into local economies.



#### **Procurement**

**Procurement** is the way we buy goods and services.

We will do the work in our Sustainable Procurement Strategy 2022-26 to have:

- value for money
- benefits to HES, society and the economy of Scotland
- as little damage to the environment as possible



#### **Skills**

We will work with our partners on our Skills Investment Plan to:

- increase the availability of skills we need to look after the historic environment, like stonemasonry
- attract people to work in the historic environment
- improve access to jobs in the historic environment
- encourage new and different ways of working

The historic environment is the story of Scotland.

The traditions, songs and customs that connect people to places bring the past to life.

Celebrating and sharing these stories is just as important as looking after the places they are connected to.

#### **Outreach and learning**


We will provide a mixture of different learning opportunities
