INTRODUCTION

Historic Environment Scotland manages a diverse range of assets. These assets include physical operational infrastructure, extensive archives and collections, datasets and other forms of information. Some of these assets are historic in nature, others are more contemporary. In delivering our functions, we generate new information assets on a daily basis. How we deploy and manage those assets has the potential to add significant value to our corporate objectives and to realise benefits for others.

I.0 DEFINING ASSET MANAGEMENT

ISO 55000 defines asset management as the "co-ordinated activity of an organisation to realise value from assets". In turn, assets are defined as "An asset is an item, thing or entity that has potential or actual value to an organisation".

Asset Management involves the balancing of costs, opportunities and risks against the desired performance of assets, to achieve the organisational objectives. This balancing might need to be considered over different timeframes. Asset Management is the art and science of making the right decisions and optimising the delivery of value (courtesy of the Institute of Asset Management).

Our assets may be defined as being human, physical, intangible and information in nature in line with a standard organisational asset model.

2.0 CONTEXT FOR ASSET MANAGEMENT

The delivery of asset management sits within a broader legislative and policy context of Scotland's strategy for the historic environment, *Our Place in Time*. Historic Environment Scotland's (HES) corporate objectives are aligned with contributing to and delivering this strategy and the delivery of asset management has significant potential to contribute to both. As the lead public body for the historic environment, HES can set an example to the sector to lead, enable and innovate through the management of our own assets.

Our Asset Management is closely aligned with our Corporate Plan in delivering our vision, mission and the outcomes from our five strategic themes.

3.0 STRATEGIC ASSET MANAGEMENT IN HES

A sound approach to the management of our assets of all forms is critical to our strategic and operational success.

Understanding the needs of these assets, their development, decline and renewal allows us to make informed decisions on their care and ensure we have the right competences and systems to manage them effectively.

Good-quality data asset management ensures evidence-based decision-making and prioritisation,

and acknowledgement that there are inevitably gaps in our knowledge base.

Our asset management is embedded in our Corporate Plan and Operating Plan. In broad terms, the assets of Historic Environment Scotland can be codified using the Organisational Asset Model.

Particular asset management disciplines and teams are focused on particular areas. Discreet assets have specific strategies, work plans and programmes. This is illustrated in the table opposite.
